

6.1.2.1 Proof-of-Time Requirement

Existing

Middle Atlantic may impose a fine of \$50 per event on any MA swimmer who enters an event having qualifying times in a MA Circuit Meet (see following) and then fails to swim the qualifying time in that event unless proof-of-time for that event can be provided. Swimmers disqualified in any such event are considered not to have swum the entry time and will be similarly required to provide proof-of-time. Any swimmer not providing such proof-of-time will be suspended from further competition in MA Circuit Meets until the fine is paid. Proved times must be from a USA Swimming Sanctioned, Approved or Observed Meet or a MA Accepted Meet. Except for UNattached swimmers, request for proof-of-times and imposed fines will be administered via the swimmer's Club.

The MA Circuit Meets shall include: Fall Classic, Elite Invitational, Short Course Junior Olympics (Spring), Long Course Junior Olympics (Summer), the MA Senior LC Championships, and any other meet hosted or sponsored by the Middle Atlantic Senior or Age-Group Committees.

Proposed

Middle Atlantic may impose a fine of \$50 per event on any MA swimmer who enters an event having qualifying times in a MA Circuit Meet (see following) and then fails to swim the qualifying time in that event unless proof-of-time for that event can be provided. Swimmers disqualified in any such event are considered not to have swum the entry time and may be similarly required to provide proof-of-time. Proved times must be from a USA Swimming Sanctioned, Approved or Observed Meet or a MA Accepted Meet. Any swimmer not providing proof-of-time when required will be suspended from further competition in MA Circuit Meets until the fine is paid. All fines and/or suspensions may be appealed to the MA Board of Review. Except for UNattached swimmers, request for proof-of-times and imposed fines will be administered via the swimmer's Club.
