This is a pre-seeded Timed Final meet. It is open to all swimmers who are currently registered with USA Swimming. No proof of time is required. The 2002 USA Swimming rules will apply.

This meet is a Last Chance meet for the 2002 Long Course Junior Olympic Meet. JO Registration entry forms will be available at the meet.

Facility: 6 lane 50-meter long course outdoor pool, non-turbulent lines, Colorado 5000 timing system. Water depth at the start end is 4 feet. Parking lots adjacent to pool. Deck access is limited to swimmers and coaches displaying current USA Swimming credentials, and essential meet personnel. Emergency contact day of meet: Call cell #717-951-5370

Eligibility: Open to all swimmers with current USA Swimming registration. Swimmers age determined as of July 12, 2002.

Entries: Swimmers are limited to 4 events per day. All entries must be submitted in the course in which they were achieved. Entries should be submitted using Hy-tek Commlink software on a 3.5" diskette. A printed hard copy from Team Manager, listing swimmers alphabetically and listing each swimmers events must accompany the diskette. All times are to be swimmers best times per USA Swimming Rules. The meet director reserves the right to limit the heats, entries, or eliminate events to conduct the meet within a reasonable time span. Eliminated swims will receive a full refund. A \$5.00 per swimmer surcharge will be charged for teams with 5 or more swimmers whose entries are not on disk. Deck entries will be accepted at the meet director's discretion. Deck entries will be \$6.00 per individual entry and will swim for time only.

Entries Due: All entries must be received by Friday June 28, 2002. **Entries will be accepted on a first come basis. MA teams will be given preference, if their entries are received by June 21, 2002.** For conformation notification please send self addressed, stamped post card. Faxed entries will not be accepted.

Entry Fees: \$4.00 per individual event. Checks made payable to Lancaster Aquatic Club
Entries will not be accepted without entry fee check. One check only per team.

Middle Atlantic safety rules and warm-up procedures apply. All swimmers should be familiar with these rules. Any swimmer disregarding the rules could be suspended from the meet at the discretion of the Meet Referee.

Final Results: Results will be posted on the MA website immediately after the meet at www.maswim.org. Disk entries can be given to those teams who sent entries on disk. Copies of final results may be ordered from meet director for \$6.00.

Warm-Up: All warm-ups are OPEN warm-ups. Sprint lanes will be available the last 15 minutes of warm-up. Swimmers without a coach must report to the Meet Director prior to entering the pool for lane assignment.

Directions:

From NJ & East & West: Take PA Turnpike to exit 21. Proceed straight from the tollbooth to the light. Turn left onto RT. 272 South and follow to Rt. 322 East. Take 322 East, through the next traffic light and across the bridge. After the bridge, make a sharp right turn and proceed to the stop sign. The pool is straight ahead.

From South: Take Rt. 30 East to Rt. 222 North. Take Rt. 222 to Brownstown exit. Turn right off the exit ramp. Go to the light (Rt. 272) turn right. Continue on 272 north to 322 East. Take 322 East through the next traffic light and across the bridge. After the bridge, make a sharp right turn and go straight ahead to the pool.

From Reading & North: Take Rt. 222 South to the Reamstown/Denver exit. Turn right and proceed to the T intersection. Turn left onto Rt. 272 South and follow until you come to Rt. 322 East. Take 322 East, through the next traffic light and across the bridge. After the bridge, make a sharp right turn and proceed to the stop sign. The pool is straight ahead.

- 1.) * The 1500 Freestyle will be deck seeded swum fastest to slowest alternating women and men. Positive check-in for this event will close at 11:30 AM Friday July 12, 2002. Swimmers must provide their own counter and timer. This event may be limited to 3 heats of women and 3 heats of men in order to fall in the 4-hour session rule. Swimmers cut will be refunded entry fees. At the discretion of the Meet Director and if time permits, anyone wishing to swim the 800 freestyle will be seeded in the slowest heats.
- 2.)** Event # 29-30 the Senior 400 Freestyle may be limited to the top 30 swimmers in each event.
- 3.) Meet Director reserves the right to limit any event in order to comply with the 4-hour time rule.
- 4.) Swimmers eliminated from events due to time limitations will be given first priority for deck entry in an alternate event on the day of the meet.
