### ELIGIBILITY:

The meet is open to any USA registered swimmer. Swimmer's age as of **February 9, 2008**, governs age group participation for the entire meet.

### ENTRY

#### LIMITATIONS:

Meet management may add sessions, shift an event, limit the number of entries, eliminate certain events and/or heats, and any other reasonable modification to the meet format in order to complete sessions within the four (4) hour session limit. Notice will be provided promptly to swimmers and teams concerning modifications to the meet or changes to any entries/events/heats. Entry fees will be refunded to teams/swimmers whose entries have been rejected or who are unable to compete due to limitations.

### WARM-UPS:

**ASSIGNED WARM-UPS:** There will be two 25-minute periods per session. Sprints are included as a 5-minute segment of each warm-up period. Additional warm-up sessions may be added if necessary. Lane assignments will be included in coaches' packets and posted around the pool deck.

### RULES:

Current USA and Middle Atlantic LSC rules will govern the meet. **'Fly-over' starts will be used at this meet. All swimmers (except for Backstroke starts) should remain in the water at the completion of their race until the next heat has begun.** USA swimming/ MA swimming safety guidelines and warm-up procedures will be in effect for the entire meet. Only currently credentialed coaches, USA swimming registered athletes and meet personnel will be permitted on deck.

Penalties will be imposed on swimmers (in accordance with USA/MA LSC rules) when any coach, parent, or swimmer enters a time other than a best time, for any event. Failure to swim in a deck seeded event after checking in will result in a 1-event penalty. The swimmer will not be allowed to swim in their next individual event.

Any swimmer observed swimming under or through the bulkhead by an official or Safety monitor at the meet will be disqualified from that swimmer's next individual event or from the remainder of the meet, as determined by the meet referee. This Policy will be strictly enforced.

**SURCHARGE:**

Teams/swimmers cannot avoid the surcharge by submitting individual entries for swimmers.** Meet management will bill individuals when a team's entries exceed the limit of five. Failure to remit payment will result in rejection of entries.

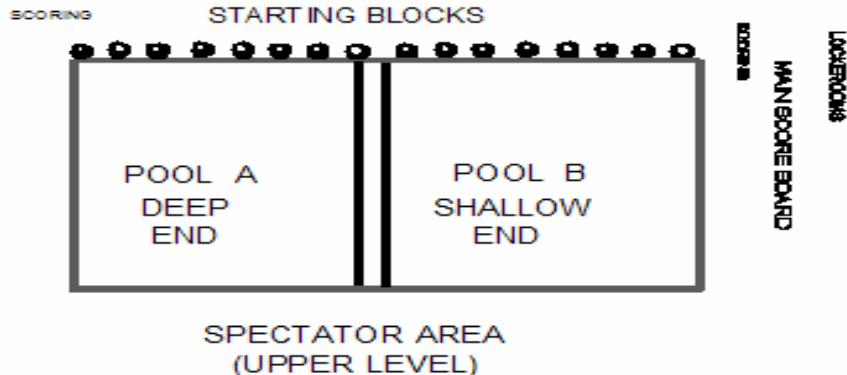

**ADMISSION:**

FREE ADMISSION / \$5.00 PROGRAM PER SESSION.

**RESULTS:**

Final results will be posted on the Wahoos website within 48 hours of the conclusion of the meet and transmitted to all clubs that sent an entry via E-mail. Results will also be posted on the Middle Atlantic website. Results will NOT be mailed.

**DECK ENTRIES:**

Deck entries may be accepted at the discretion of the meet director as non-award swims.

**COST:**

\$8.00/event. Limited to one event/swimmer per day. Swimmers not already in the meet must present proof of current USA swimming registration. See Meet Director.

**VOLUNTEERS:**

Free admission/refreshments will be provided to anyone who volunteers as a timer, runner, or other capacities designated by the meet director.

**SWIMMERS**

Swimmers unaccompanied by a credentialed coach must report to the meet director prior to warm-ups for each session.

**W/OUT COACHES:**

**SPECTATORS:**

Seating is first come/first served. Spectators are prohibited from the deck.

**DIRECTIONS:**

**From the south:** take route 55 north to route 47. Take exit 56b/westville. Turn left at the traffic light onto Bankbridge road. Turn left at the next traffic light onto Tanyard road. The entrance to GCIT is on the left at the bottom of the hill.

**From the north and the Walt Whitman bridge:** take I-295 south to route 42 south and remain in right lane. Take route 55 south to exit 56B (route 47 north/Woodbury). Turn left onto Bankbridge road at the traffic light. Turn left at the next traffic light onto Tanyard road. GCIT is on the left at the bottom of the hill.

**From the Delaware Memorial & Commodore Barry bridges:** take I-295 north to exit 21 onto Delaware St. and continue through Woodbury. Turn right at traffic light onto Evergreen Ave. Turn left at next traffic light onto Egg Harbor road. Continue 3-miles to the next traffic light. GCIT is at the bottom of the hill on left.
