A snack bar will be provided for spectators.

ELIGIBILITY	This meet is open to eight and under swimmers registered with USA Swimming for 2008. The 2008 USA Swimming rules will apply. Swimmer's age is as of the first day of the meet. Age Group is determined by the swimmer's age as of October 19, 2008. Each swimmer may compete in a maximum of FIVE (5) individual events and ONE (1) relay.

<p>ENTRY LIMITATIONS</p>	<p>The Meet Director reserves the right to limit entries, events or heats, or to modify the meet format to conform to Middle Atlantic rules.</p> <p>Due to limited deck space, this meet will be limited to 150 total swimmers.</p> <p>Swimmers/teams eliminated from the meet due to time or space constraints will be given a full refund.</p>
<p>ORDER OF EVENTS</p> <p>WARM – UP & START TIMES</p>	<p>See the attached sheet listing the order of events, and event numbers.</p> <p>USA Swimming and Middle Atlantic safety procedures will be enforced throughout the meet.</p> <p>Warm ups – warm up session is an open session starting at 12:00PM.</p> <p>Meet start time 1:00PM.</p> <p>Sprint lanes will be opened 20 minutes before the start of the meet.</p> <p>Feet first entry until sprint lanes opened. The meet referee may remove any swimmer from the warm up session for failure to comply with the warm up rules.</p>
<p>DECK ENTRIES</p>	<p>Subject to space availability, and at the discretion of the Meet Director, deck entries will be accepted on the day of the meet, prior to the start of the meet, at the cost of \$8.00 per individual event, Relays \$ 12.00. Deck-entered swimmers will compete unofficially; the achieved time is official, but will not score in the meet for awards. Swimmers not already entered in the meet must provide proof of current USA Swimming registration.</p>
<p>SWIMMERS WITHOUT A COACH</p>	<p>Swimmers unaccompanied by a credentialed coach should report to the Meet Director before the warm-up for each session. Swimmers without a coach will swim with and be supervised by the host club during warm-up.</p>
<p>SEEDING</p>	<p>All events in this meet are Pre-seeded, timed finals.</p>
<p>HOW TO ENTER</p>	<p>No converted times will be accepted. Entry times must be submitted in the course in which they were achieved. Non conforming times will be seeded in the slowest heats.</p> <p>Swimmers without a valid USA Swimming time will be entered as “NT”.</p> <p>Entries should be submitted using HY-TEK software, via email to the meet director. A word or pdf entry file must accompany the HY-TEK file.</p> <p>If using HY –TEK is not possible; the Official Entry Form must be used.</p> <p>A completed Meet Summary Sheet must accompany each team’s entry.</p> <p>Please waive the Signature release for priority mailings.</p> <p>No phone entries will be accepted.</p> <p>No meet entries will be made prior to receipt of fees, by the posted deadline.</p> <p>A \$5.00 surcharge per swimmer will be added for each team with 5 or more</p>

	<p>entries that does not submit entries on HY-TEK disk format.</p> <p>We request each club submit one check payable to “Lancaster Aquatic Club”</p> <p>Notice: As per Middle Atlantic regulations, failure to enter a swimmer’s best time could result in suspension from competition for a minimum of three months, but not more than one year. Further violation by a coach, parent, or swimmer could result in that person being forbidden to participate in or attend USA Swimming functions.</p>
ENTRY FEES	<p>\$4.00 per individual event. Deck entries \$8.00. Relays \$8.00 per Relay. \$5.00 per swimmer surcharge for teams of 5 athletes or more submitting entries manually.</p>

RULES	<p>This meet will be conducted according to current USA Swimming rules. Middle Atlantic Swimming rules shall also apply. USA SWIMMING / MA SWIMMING SAFETY GUIDELINES AND WARM-UP PROCEDURES WILL BE IN EFFECT FOR THE ENTIRE MEET.</p> <p>Only currently credentialed coaches, USA Swimming registered athletes and essential meet personnel will be permitted on deck.</p> <p>This meet will be conducted using the Whistle command, supplemented with verbal commands, and No-Recall False Start procedures.</p>
SCORING & AWARDS	<p>Individual Events – Medals 1st – 3rd, Ribbons 4th – 8th.</p> <p>Relays – Ribbons 1st -3rd.</p>

PROGRAMS & ADMISSION	<p>Adults - \$4.00 for admission and program.</p> <p>Children under 12 – free admission.</p>
RESULTS	<p>Results will be posted on the Middle Atlantic website www.maswim.org and the Lancaster Aquatic Club website, www.lancasteraquaticclub.com</p> <p>Hard copies of meet results will be available for \$10.00 per copy, see MD to order.</p> <p>No disks will be copied with final meet results.</p>
DIRECTIONS	<p>From West – Take PA Turnpike to Lancaster exit, (I-283 Exit 247). Just past toll booth bear right onto Rt. 283 East toward Lancaster. Follow Rt. 283 to Pa-722 exit. Turn right at end of off ramp onto State Road. Proceed to the traffic light at Harrisburg Pike. Turn left onto Harrisburg Pike. Pool is 1.3 miles on the left.</p> <p>From North – South via Rt. 81. Take the exit for Harrisburg and follow Rt. 83 South 3 miles until the exit for Rt. 283. Then follow directions from the west.</p> <p>From East – Follow Rt. 30 West, exit at Harrisburg Pike (same exit as Franklin and Marshall). Turn RIGHT onto Harrisburg Pike. Follow Harrisburg Pike past the Lancaster Health Campus, cross Rt. 741, pool is 0.3 of a mile on right.</p> <p>From South – Rt. 83 North to US Rt. 30 East. Exit Pa-741. Turn left onto PA-741 Rohrerstown Road. Turn left onto Harrisburg Pike; pool is 0.3 of a mile on right.</p>
