January 22-24, 2010**

Please note important Information for 2010 Elite Meet:

- **THE MEET FORMAT HAS BEEN CHANGED TO A FULL 3-DAY FORMAT.**
See the Event Schedule for the new Order of Events.
- **GCIT School is in session on Friday, January 22; please read the sections below that contain essential information on parking and other restrictions on that day.**
- **ENTRIES AND CHECKS MUST BE SENT DIRECTLY TO THE MEET DIRECTOR. DO NOT SEND ANYTHING TO THE MIDDLE ATLANTIC OFFICE.**
- **There is a \$5 surcharge for each swimmer entered in the meet, including Relay only swimmers.**
- **The top eight (8) seeded 11-12, 13-14 and Senior Relays will swim at Finals; all other relays will swim during Prelims. The 10/U Relays will swim at the end of the afternoon sessions.**
- **All swimmers should be entered in the Meet prior to the closing of entries, including Relay-only swimmers.**
- **The 11-12 500 Free and 400 IM are Timed Final events. The 13 and over 500 Free and 400 IM events are Prelims/ Finals.**
- **The fastest eight (8) swimmers (from combined 11/12, 13/14 and Senior age-groups) seeded in the 1000 and 1650 Free (based on conforming SCY entry times) will swim at Finals. The fastest eight (8) swimmers seeded in the 11-12 500 Free and 400 IM will swim at Finals. Swimmers with another individual event on the day of these events may enter the distance event at the SCY time standard to obtain an early swim.**

Eligibility: This Meet is open to all swimmers currently registered with USA Swimming who meet the qualifying time standard in an event. Age group is determined by the swimmer's age on January 22, 2010. Qualifying times must have been achieved on or after September 1, 2008. Each swimmer is limited to three (3) individual events and one (1) relay per day.

Facility: The GCIT Aquatics Center, located on the campus of the Gloucester County Institute of Technology, has two 8-lane/25-yard courses equipped with Competitor non-turbulent lane lines; water depth is 12 feet and 5 feet at starting ends. GCIT has Colorado timing systems on each pool with an 8-lane scoreboard on the deep pool and a 1-lane scoreboard display on the shallow pool. There is balcony seating for spectators with a capacity of 450.

Parking: **Parking in the GCIT parking lot will be limited to essential meet officials and personnel only on Friday until 3:30 pm. Swimmers may be dropped off at GCIT from 6:30 am until 7:20 am and during a designated time for the 10 and under session ONLY. The parking lot will be off limits at all other times on Friday. Parking will be available in designated areas at Gloucester County College located next to GCIT. Shuttle buses will run between GCIT and the Gloucester County College parking area throughout the day.**

Entries: All entries MUST be submitted using the Hy-Tek Team Manager or compatible program using swimmer information generated by the Team's registration database and identical to that in the SWIMS database. Teams may either (a) send a computer disk containing the entry information, a Hy-Tek entry report, the Meet Summary Sheet and check to the Meet Director, or (b) send the electronic entry information and entry report via E-mail to EliteMeet@maswim.org ; then send the Meet Summary Sheet and check to the Meet Director. **DO NOT SEND ANYTHING TO THE MIDDLE ATLANTIC OFFICE. See protocol for e-mail entries below.** Please waive the 'signature required' if your entry is sent via a Postal Service that provides one. **Do not send a disk if you e-mail your entries. MANUAL ENTRIES FROM CLUB SWIMMERS WILL NOT BE ACCEPTED!** This insures that all results achieved by the swimmer will be correctly assigned to that swimmer in the SWIMS database.

Protocol for e-mail entries:

- 1) Subject line should read "your team name" entry for Elite 2010.
- 2) Include # of swimmers, individual events and relays in the text of the e-mail.
- 3) Provide contact name and information.
- 4) Attach exported entry file and entry report.

Swimmers must enter their best time in an event (except certain distance events – see below.) All times submitted must be for the course in which they were achieved; converted times are not acceptable. Non-conforming times will be seeded according to USA Swimming policy (Rule 207.12.7B).

Deck entries will not be accepted at this Meet.

Proof-of-Time: Middle Atlantic Swimming will require proof of entry time from any swimmer who does not swim the Qualifying Time at the Meet. Middle Atlantic swimmers who cannot prove their entry time (in the course swum) will be fined \$50 and may be suspended from competition in Middle Atlantic hosted meets until the fine is paid.

Entry Fee: \$ 4.00 per individual event.
\$ 8.00 per relay entry.
Make checks payable to: “Middle Atlantic Swimming”; please submit one check per Club.

Entry Deadline: All entries must be received by **2:00 p.m., Monday, January 11, 2010**. No late entries will be accepted. Entries will be processed on a ‘first come, first entered’ basis. Middle Atlantic reserves the right to limit the number of entries to keep each session within a reasonable time limit. Refunds will be given for eliminated events. **Entries will not be processed without payment of the entry fees. Checks for electronic entries must be received by Wednesday, January 13 or the entries may be deleted.**

Awards: Individual events: Medals for 1st - 8th places
Relays: Medals for 1st - 3rd places

A High Point Team Award will be presented to the top three Teams based on overall points.

A High Point Swimmer Award will be presented to the top scoring Boy and Girl in each individual Age Group.

Finals: All 10 & Under events are Timed Finals, swum in the afternoon session only.
11/12, 13/14 and Senior age groups will swim an A- and B- Final in the evening Finals session, except the 11/12 age 200 Back, 200 Breast, 200 Fly, and the 13-14 and Senior 500 Free and 400 IM events, which will swim an A-Final only.
The B-Final will precede the A-Final at Finals.
The 1000 Free and 1650 Free and the 11/12 500 Free and 400 IM events are Timed Finals.

Relays: All relays will be swum as Timed Finals. The top eight (8) seeded entries in the 11 and over relays will swim at the end of Finals; the remaining relays will swim during the morning Prelims. (Note: Relays seeded in the top eight will have the option to swim in the morning only if another relay agrees to swim at Finals.) All 10 & Under relays will swim at the end of the afternoon sessions. Positive check-in will be required to be seeded. (Note: Relay-only swimmers added at the meet MUST provide proof of registration, including complete registration ID information. Any Club that enters a relay-only swimmer not eligible to represent that Club will be subject to further penalties by the MA Board of Review.)

Scratch policy: Any swimmer who does not swim a pre-seeded Preliminary or pre-seeded Timed-Final event will not be penalized. Any swimmer who positively checks-in for a deck-seeded event and does not swim that event will be barred from their next individual event, either on the same or next meet day; swimmers may take a DFS in a Timed Final event (except those seeded into the 11&over 1000/1650 Freestyle and the 11-12 400 IM and 500 Free heats at Finals). Any swimmer who qualifies for Finals in a Preliminary/Finals event and does not report for and swim the Finals will be barred from the rest of the Meet (including Relays) unless the swimmer has scratched, or indicated their possible intention to scratch, to the Admin Referee within thirty (30) minutes of the announcement of the Preliminary results. Swimmers declaring possible intention must confirm their intention to scratch within thirty (30) minutes of the announcement of the results of that swimmer’s last individual event at the Preliminary session or they will be seeded into the event and expected to swim. Swimmers who are initially announced as Alternates for the Finals will not be so penalized.

A \$50 fine will be imposed on any MA swimmer who qualifies for Finals on the last night (or last day of competition for that swimmer) and then does not compete in that event, unless such swimmer has appropriately scratched or is otherwise excused from the event.

Seeding: All 400 IM, 500 Free, 1000 Free and 1650 Free individual events and all Relays will be Deck-seeded; all other events will be Pre-seeded. Positive check-in is required to be seeded into Deck-seeded events.

All Preliminary events will swim slow-to-fast. The 11-12 400 IM and 500 Free heats at Prelims will swim slow-to-fast; the 1000 and 1650 Free heats at Prelims will swim fast-to-slow. The 9-10 500 Freestyle will swim slow-to-fast. The top eight seeded swimmers (from combined Senior, 13/14 and 11/12) in the 1000 and 1650 Free and the top eight seeded swimmers in the 11-12 500 Free and 400 IM events will swim at Finals; once seeded, these swimmers will not have the option to swim the event during Prelims except at the discretion of the Meet Referee. Check-in for the 1000 / 1650 Free and 11-12 500 Free events will close at 10:00 a.m. on the respective morning; check-in for the 11-12 400 IM will close at 8:00 am on Sunday. **All** swimmers must check in by the morning deadline.

Time Trials: Time Trials will be available at times to be determined by the Meet Referee for a fee of \$10.00 per individual swim and \$20.00 per relay. To swim a Time Trial, a swimmer must have a qualifying time within 0.5-sec per 50-yd of the Eastern Zone Sectional Time Standard for that event. A swimmer may swim one Time Trial per day in an event, and a maximum of two Time Trials per day. A Time Trial event counts toward the allowed limit of three (3) individual events each day. Time Trials are open to any USA Swimming registered swimmer. Time Trial swimmers not entered in the Meet must provide proof of current USA Swimming registration.

Distance Events: Swimmers with qualifying times in the 1000 or 1650 Free, or the 11-12 500 Free or 400 IM, may enter those events using their fastest time, or may enter at the SCY time standard provided they are entered in at least one other individual event on the day of the distance event.

Sprint and pace lanes will be opened approximately thirty minutes before the start of each session.

The morning Prelims for 11/12, 13/14 and Senior events will be held in both courses, and will alternate Friday, Saturday and Sunday. The 10/Under Timed Finals sessions, and the evening Finals sessions will be held in the deep pool. The events at Finals will be swum in numerical event order, except that the 1000 and 1650 Free events will be the first events on Friday and Sunday evenings, respectively.

Officials: Officials attending and planning to work at this meet may contact the Meet Referee, Jim Leigh at jim.leigh@comcast.net or (215) 572-0787 prior to the meet. Available Officials that have not made contact prior to the meet should report to the Referee at the start of warm-ups for any session.

This meet may be an Officials Qualifying Meet (OQM) for those officials seeking advancement or renewal of their N2 or N3 (S&T only) certification. Officials wanting to renew or advance their N2 certification should contact the Officials Chair at officials@maswim.org.

Safety: USA Swimming and Middle Atlantic safety procedures will be enforced during the Meet. There shall be no diving during Warm-up, except in designated sprint lanes. The Referee may remove anyone from warm-up for failure to comply with the Warm-up rules. Swimmers without a Coach should report to the Referee prior to entering the pool to obtain assignment to a Team for that session.

Any swimmer observed swimming under or through the Bulkhead by an Official or Safety Monitor will be disqualified from that swimmer's next Individual Event or from the remainder of the Meet, as determined by the Meet Referee. This policy will be strictly enforced.

Deck ID: Only SWIMMERS, COACHES, OFFICIALS and MEET VOLUNTEERS are allowed on Deck. All Coaches must display their current 2010 USA Swimming Coach's Membership Card. This requirement will be strictly enforced! Spectators may view the Meet from the balcony.

Admission: Free

Programs: A 3-day Program will be sold for \$10. Included in the program are coupons that may be redeemed for a Finals program at night. Finals Programs can be purchased for \$2.

Final Results: Meet Results will not be mailed to the entered clubs. Meet results will be available on the Middle Atlantic Website.

Team Work Assignments: This Meet is sponsored and administered by Middle Atlantic Swimming. MIDDLE ATLANTIC CLUBS WILL BE RESPONSIBLE FOR PROVIDING VOLUNTEER WORKERS BASED ON THE NUMBER OF THEIR SWIMMERS ENTERED IN THE MEET. This requirement is necessary for the smooth running of the Meet. Each Team's contact person will be notified of their Team's assignments. Failure to provide assigned workers could cause penalties to be imposed on that Team's entries in the Meet.

Hospitality: A Snack Bar will be available. The Gloucester County Institute of Technology school and staff administer the snack bar. Middle Atlantic Swimming has no responsibility whatsoever for the snack bar.

Directions : **FROM THE SOUTH:** Take Route 55 North to exit 56B (Route 47-N/Westville or Woodbury). Turn left at the first traffic light onto Bankbridge Road; then left again at the next traffic light onto Tanyard Road. The entrance to GCIT is on the left side of the road at the bottom of the hill.

FROM THE NORTH AND THE WALT WHITMAN BRIDGE: Take I-295 South to the merge with route 42 south. Follow 42-S to Route 55, and then take Route 55 South to exit 56B (Route 47-N/Woodbury). Turn left at the first traffic light onto Bankbridge Road; then turn left again at the next traffic light onto Tanyard Road. The entrance to GCIT is on the left side of the road at the bottom of the hill.

FROM DELAWARE MEMORIAL BRIDGE AND COMMODORE BARRY BRIDGE: Take I-295 North to exit 21 (Woodbury - Delaware Street) and continue through Woodbury. After passing through center of Woodbury, Turn right at the next traffic light onto Evergreen Avenue; then left at next traffic light onto Egg Harbor Road. Continue approx. 3 miles (past a convenience store on the left) to the next traffic light (Bankbridge Road.) GCIT is on the left at the bottom of the hill beyond the traffic light.
