LOCATION	Upper Dublin High School (UDHS), 800 Loch Alsh Avenue, Fort Washington, PA 19034 Google Map . Approximately 20 min from King of Prussia, 30 min from Philadelphia; 50 min from Wilmington, DE; 50 min. from Cherry Hill, NJ; 2 hrs from Harrisburg; 5 hrs from Pittsburgh.
FACILITIES	Upper Dublin High School Natatorium. New (2010) 40 yd, 10-lane Wallover-designed pool with moveable Stark bulkhead, non-turbulent Competitive lane lines, Colorado Timing System with 10-lane display. Water depth is 13 feet at the start end and is 7 feet at the turn end. 5-lane 25-yard warm-up/warm-down area available throughout competition. This pool has not yet been certified according to the USA Swimming Rules & Regulations. Balcony seating for approximately 400 spectators. Food concession available in lobby. Parking in lots surrounding Upper Dublin High School Athletic Complex and Upper Dublin Township Building Site and Parking Information .

ELIGIBILITY	The Meet Director will accept entries until the meet fills. Open to all registered USA Swimming athletes eight (8) years of age or younger. Swimmer’s age as of day of meet governs age group entry. The meet will be conducted according to current USA Swimming rules. Unregistered swimmers may register on deck at this meet by turning in the athlete registration form and payment to the Meet Director. The cost of registering on deck is double the normal fee (\$120 per swimmer for 2010-11 registration). This applies to all swimmers attached to a club.

	Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
ENTRY LIMITATIONS	<p>The meet director reserves the right to change the meet format if necessary to conduct each meet session in a four-hour time span. If the meet should fill, all unprocessed entries will be returned with a full refund.</p> <p>Swimmers may enter a maximum of five (5) events per day. If the meet is undersubscribed and at the discretion of the meet director, deck entries will be accepted for participants to swim 5 events.</p>
WARM-UP & START TIMES QUALIFYING TIMES	<p>Warm-up times and lanes will be assigned. Sprint and pace lanes will be assigned during warm-ups. 5-lane 25-yard warm-up/warm-down area available throughout meet.</p> <p>We will follow USA swimming and MA Swimming policies and procedures for warm-up.</p> <p>Dates and times: Sun, Jan 9 Warm-up 8:00am Meet starts 9:00 am</p>
DECK ENTRIES /TIME TRIALS	Deck entries, if time permits, are \$8.00 per event for swimmers. Please see the Meet Director for deck entries. Deck entered swimmers will compete unofficially; the achieved time is official, but will not score in the meet for points or awards. Swimmers not already entered in the meet must provide proof current of USA Swimming registration.
SWIMMERS WITHOUT A COACH	Swimmers without a coach should report to the meet director before the warm-up of each session.
SEEDING	All events are pre-seeded.
HOW TO ENTER	<p>Electronic entries (Hy-Tek Team Manager) entry file are preferred.</p> <p>Entries may be sent via e-mail to the meet director. Include with your entry file a Team Manager report by entry (saved in Word for Windows format). In the body of your e-mail, provide the number of girls, boys and entries. Include contact information (name, address, phone and cell phone).</p> <p>Swimmers failing to enter best times will result in MA Swimming imposed penalties.</p> <p>Entries and fees must be accompanied by the MASTER ENTRY FORMS with hard copy print out. No entries will be processed until fees are received. No entries will be accepted if they do not have the hard copy print out.</p> <p>We request each club remit <u>ONE</u> check made payable to "UDAC" to cover team entry fees.</p> <p>Email entries supersede all other forms of entry.</p>
ENTRY FEES	<p>Entry fees are \$4.00 per individual event.</p> <p>Swimmers not previously entered in the meet must provide proof of current USA Swimming registration.</p>

ENTRY DEADLINE	<p>Last day to submit entries December 29, 2010. No late entries will be accepted.</p> <p>As per Middle Atlantic Swimming Rules, a \$15 per swimmer fee will be charged to all entries submitted on paper rather than electronically.</p> <p>All clubs are encouraged to enter electronically, regardless of the number of swimmers entered. If this is not possible, the official entry form must be used. RULES	<p>USA Swimming / Middle Atlantic Swimming rules shall apply. USA Swimming / MA SWIMMING SAFETY GUIDELINES AND WARM-UP PROCEDURES WILL BE IN EFFECT FOR THE ENTIRE MEET. Only currently credentialed coaches, USA Swimming registered athletes and essential meet personnel will be permitted on the pool deck. This meet will be conducted using the Whistle command, supplemented with verbal commands, and No-Recall False Start procedures.</p> <p>All events are timed finals.</p> <p>Any swimmer observed swimming under or through the Bulkhead by an Official or Safety Monitor at the Meet will be disqualified from that swimmer's next Individual Event or from the remainder of the Meet, as determined by the Meet Referee. This policy will be strictly enforced.</p>
SCORING & AWARDS	<p>Awards will be presented to the following finishers.</p> <p>Individual Events: Rosettes 1st to 3rd; Ribbons 4th to 12th</p> <p>Heat Awards: Ribbons 1st; plus fun prizes for Hot Heats (one per event)</p> <p>Please pick up ribbons at the conclusion of the meet.</p>
